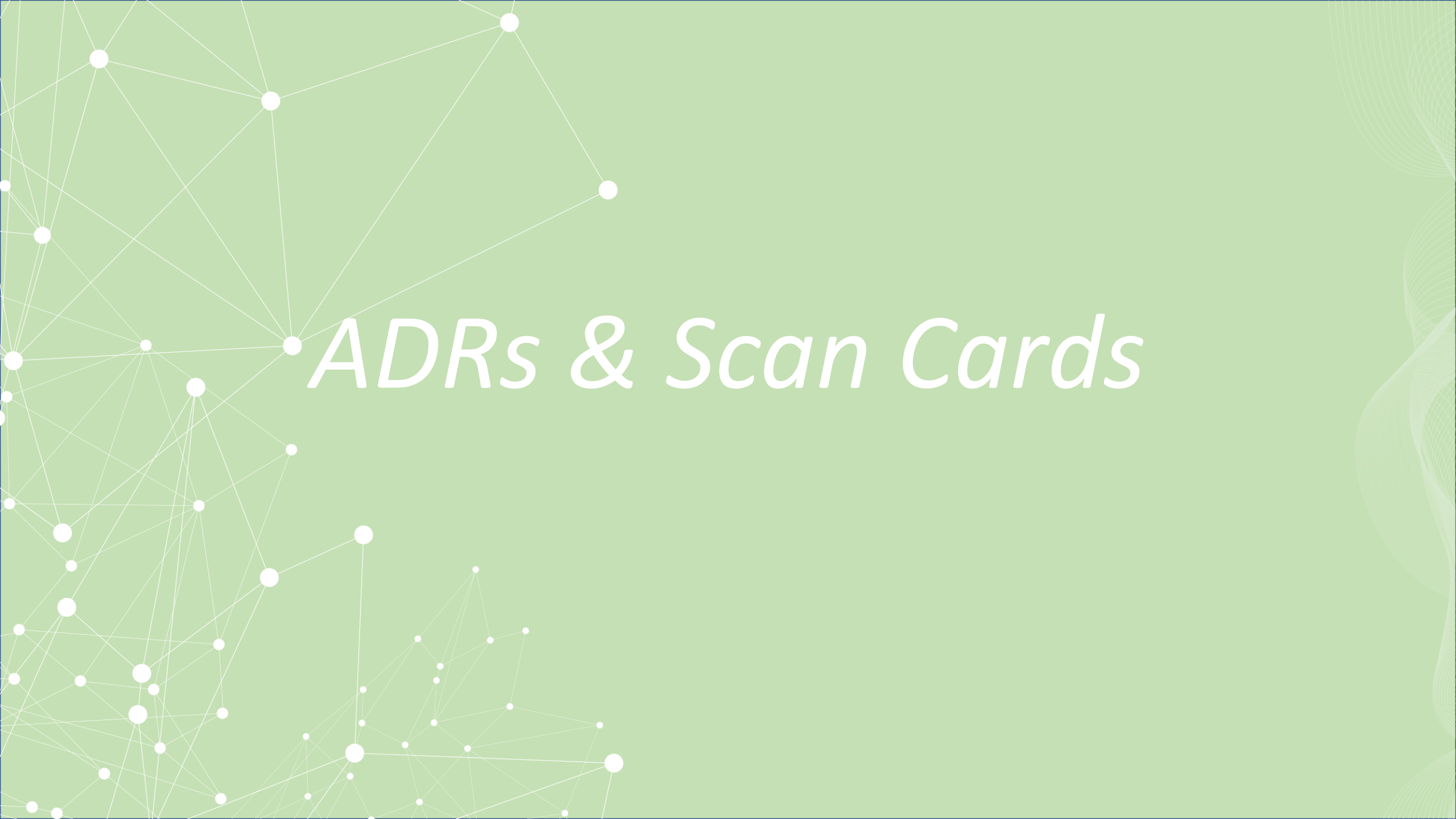

Automatic Delivery Rewards* (ADRs)

Automatic Delivery Rewards is simply the easiest way for you to receive the products you love and maintain your personal volume and eligibility. Each month, the products you have chosen are conveniently delivered to you on the day you choose. The great benefits of ADR:

- Product comes to your doorstep every month
- Increased flexibility
- Manage your account online 24/7
- Earn points toward product based on 20% of total order PSV
- Product points increase to 30% after 12 shipments on program

The Scanner qualified initial ADR:

1. Contains a **Skin Carotenoid Score (SCS) certified product** (LifePak[®]+, JVi[®], Beauty Focus Collagen+, Beauty Focus MultiBeauty)*.
2. Is **new** and not existing.
3. Is **linked to a new Scan Card number** within the right timelines.
4. Is linked to a **Scan Card used by synced Scanner**.
5. Is **registered in Europe** to count towards the Scanner programme.
6. Is **fully paid and shipped**.

Scanner qualified initial ADR

In the same ADR, you can link as many Scan Cards as many SCS certified products are.

Each product linked to a Scan Card within the right timeline counts for 1 qualified ADR.

EXAMPLE:

- A customer (John) got scanned on 01 January.
- On 15 January, John orders **1** LifePak+ and **2** Beauty Focus Collagen+ on a new ADR.
- John can now link up to a maximum of **3** Scan Cards to his ADR, which he does.
- These **3 ADRs** will now count towards your Scanner Performance.

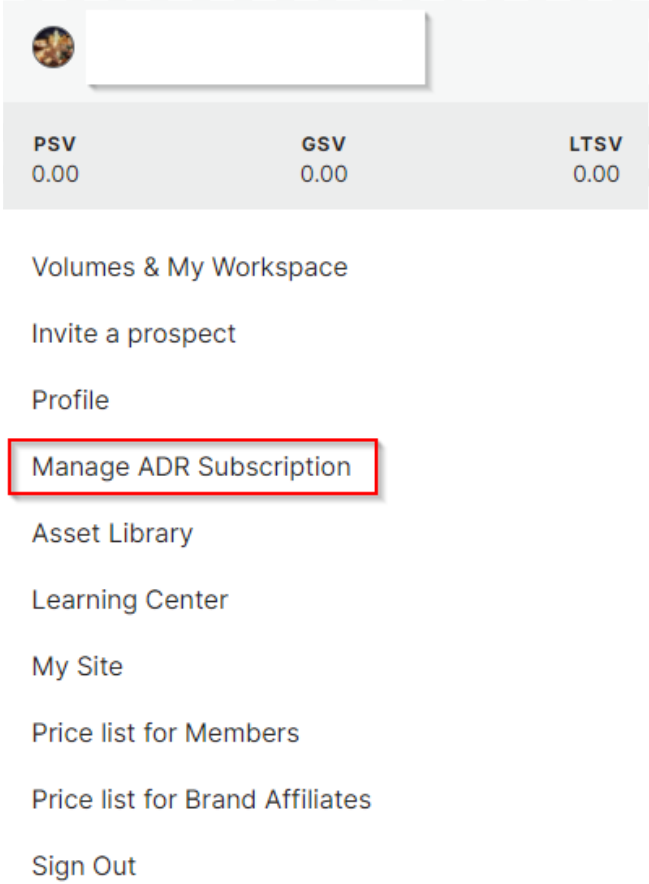

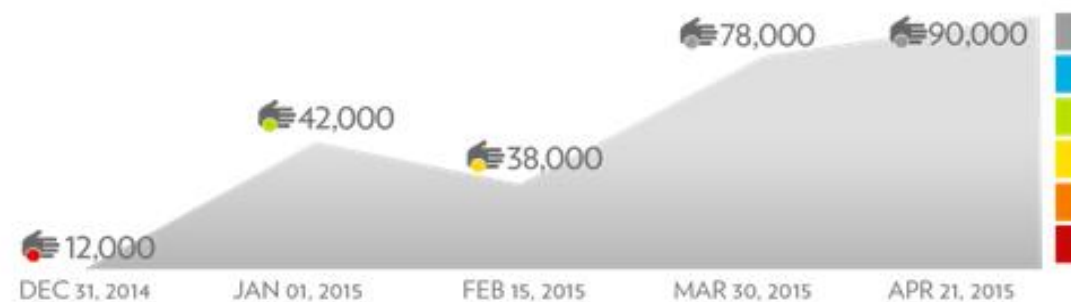

- which is following an initial ADR with a **Scan Card eligible for a free physical re-scan****
- and which is **fully paid and shipped**.

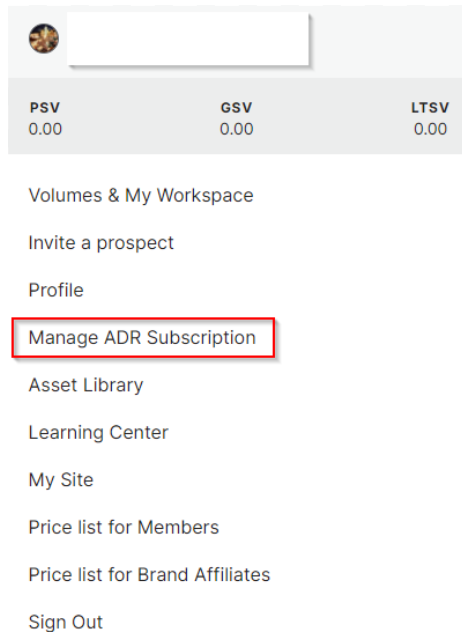

How to have a recurring ADR

1. Maintain your monthly ADR by re-ordering the SCS certified product(s) you want
2. Make a free physical rescan with your previously used Scan Card

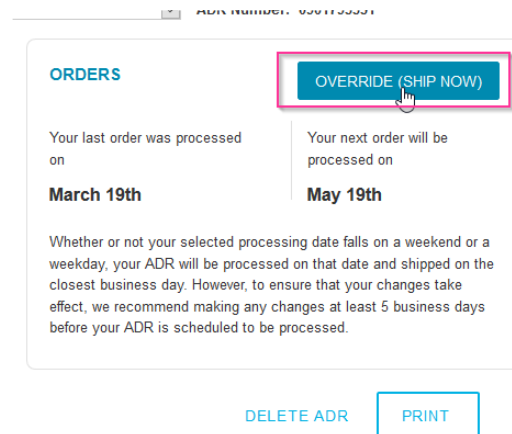
STEP 1:

Please ask your customer to log into his account, click on Manage ADR and choose his active monthly ADR



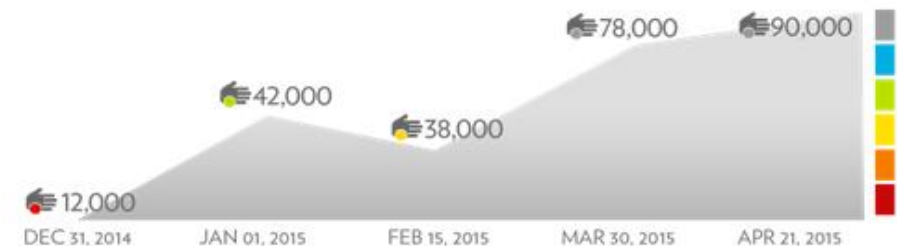
STEP 2:

Run and pay the same ADR month by month

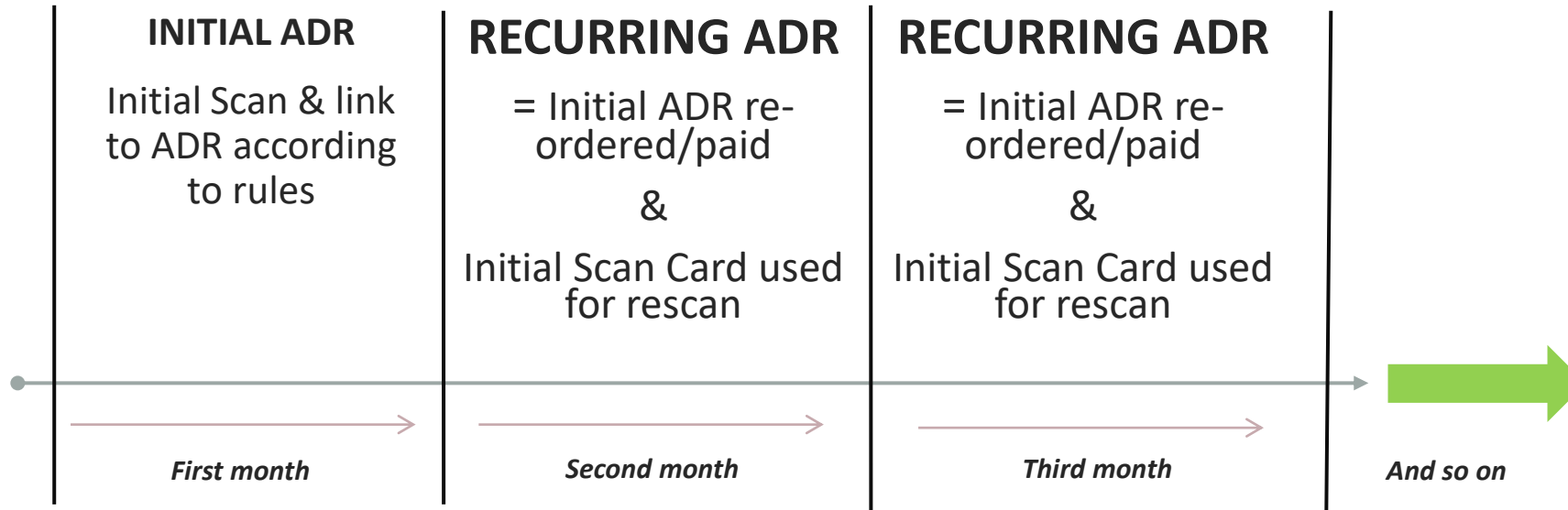


STEP 3:

Re-scan your customer physically with the same Scan Card month after month



Recurring ADR and eligibility for re-scan rule

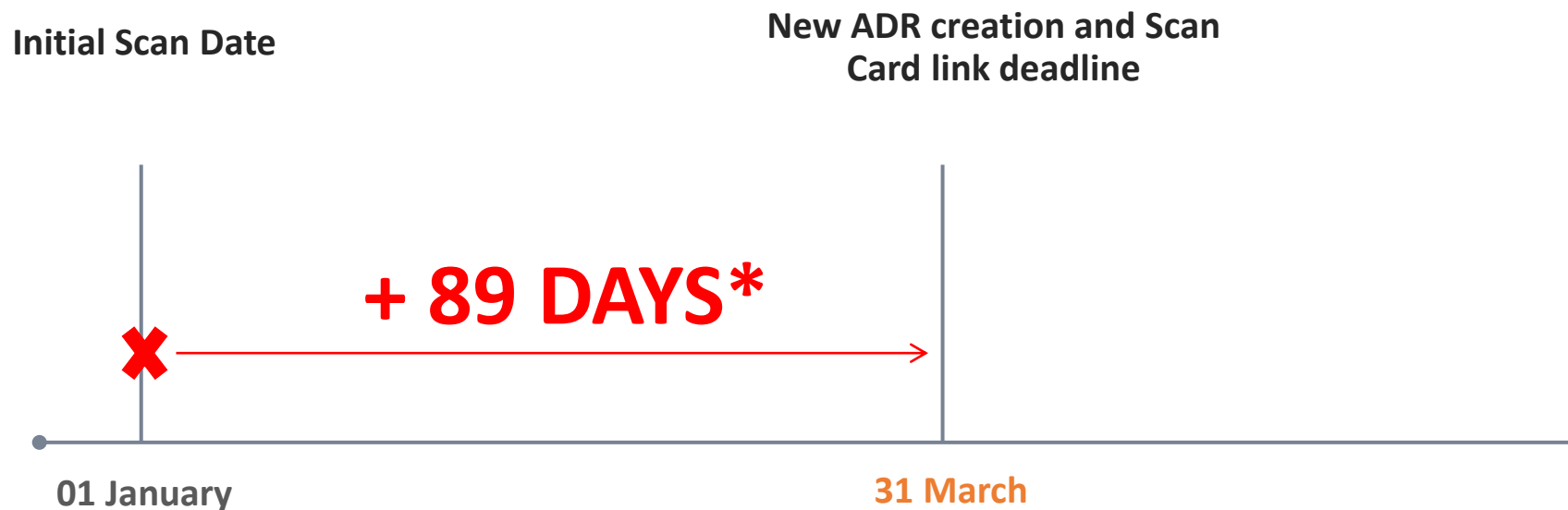


90/15 days rule to create an ADR & link a Scan Card

SCENARIO 1

FIRST A SCAN IS MADE and after a new ADR is created

**The first day when the scan or ADR is made is part of the 90/15 timelines.*



90/15 days rule to create an ADR & link a Scan Card

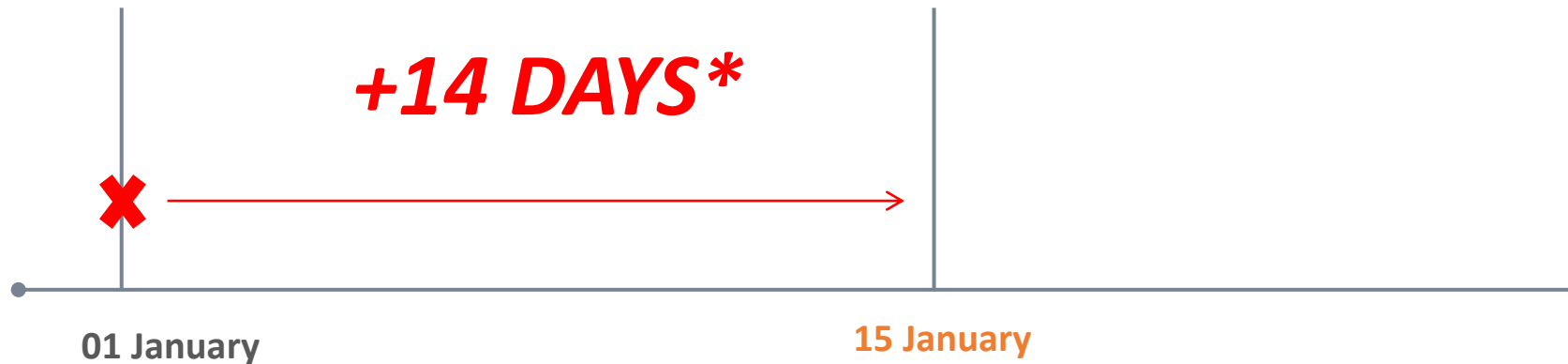
SCENARIO 2

FIRST A NEW ADR IS CREATED and after a scan is made

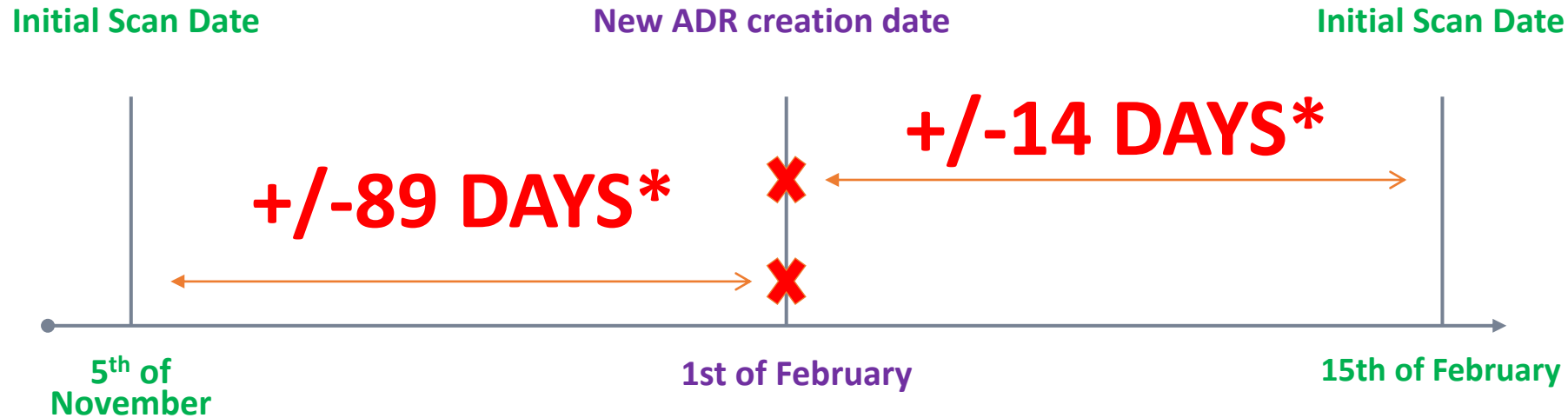
**The first day when the scan or ADR is made is part of the 90/15 timelines.*

New ADR creation date

Initial Scan & Link to

90/15 days rule to create new/initial ADR registered in Europe



**The first day when the scan or ADR is made is part of the 90/15 timelines.*

Only that **INITIAL SCAN CARD CAN BE LINKED** to the new ADR which was scanned **89 DAYS*** BEFORE the **ADR CREATION DATE** or which was scanned **14 DAYS*** AFTER the **ADR CREATION DATE**.

From the new ADR creation day, you have **+ 89 DAYS TO PAY THE ADR AND LINK THE SCAN CARD**.



If the **ADR WAS CREATED ON THE 1ST OF FEBRUARY**, only that initial scan card can be linked to this ADR which was scanned **BETWEEN THE 5TH OF NOVEMBER AND THE 15TH OF FEBRUARY**.

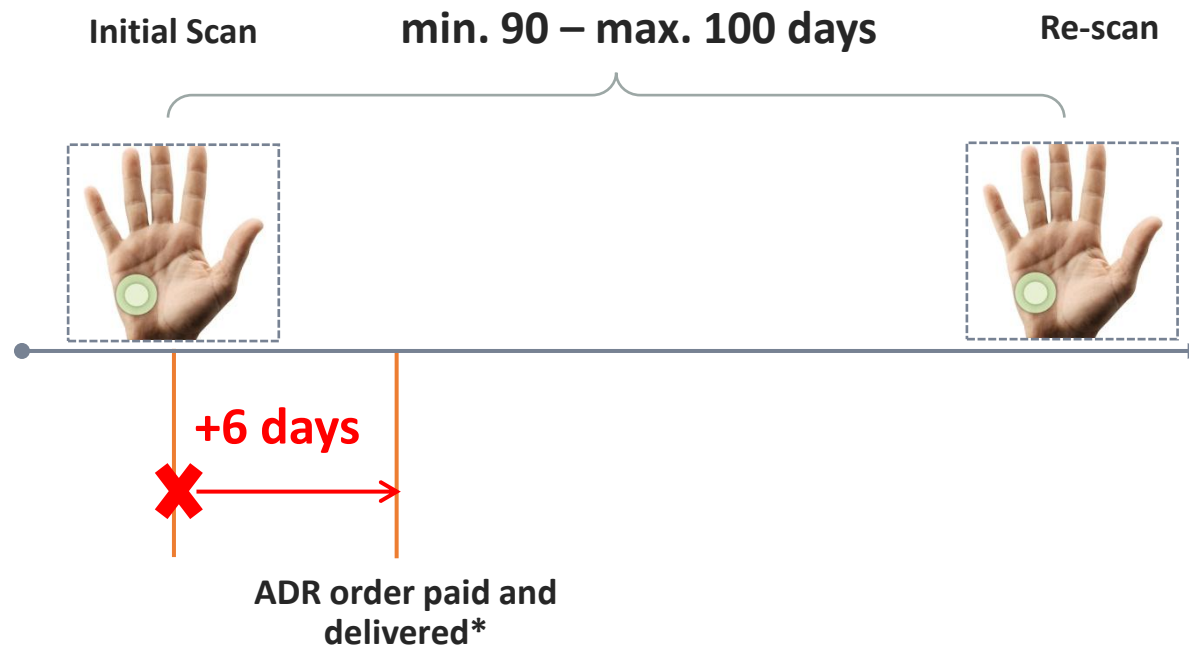
If any of the above deadlines are not met, the ADR cannot be part of that monthly scanner activity as new/initial ADR.

Money Back Guarantee

SCENARIO 3

MONEY BACK GUARANTEE eligibility timeline

**Schedule the ADR delivery date within 7 days from the Initial Scan date included.*

The best scenario for your customers and you:

1. Scan your customers physically.
2. Within a maximum of 7 days from the Initial Scan:
 - Have them order and pay for the SCS products in a new ADR so the order can be shipped.
 - Have them link the Scan Card number to their ADR order.
3. Re-scan them between 90 and maximum 100 days from the Initial Scan date.

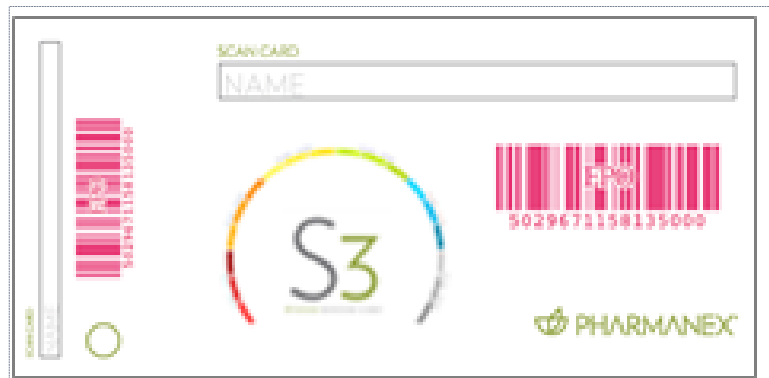

Scan Card

The Scan Card is a reusable plastic card that is a customers' access to free **LIFETIME MONITORING** of his or her SCS.

Digital Scan Cards are available at no cost exclusively to Scanner Lease Holders.*
The Scan Card number will function as initial the first time it is used and then once activated as subsequent the next times.

*Brand Affiliates can purchase digital Scan Cards by reaching out to their local Market Scanner Coordinator. Physical Scan Cards can be purchased by both Scanner Lease Holders and Brand Affiliates through the Nu Skin website

The Scan Card number is the 16 digit number written at the bottom of the bar code

Terms of Purchase: Digital Scan Card Credits

Please be aware that the attribution* of digital scan card credits ("credits") is conducted entirely in a **digital format**. As a result, you will not receive a physical copy of your scan card number or a paper receipt.

It is important to note that neither purchased nor free the credits are **non-refundable** and **cannot be transferred** to another account. By purchasing the credits, you acknowledge and agree to their non-refundable and non-transferable nature for the current and any other future credit purchases.

Lifetime Monitoring

As long as the customer stays on the **paid** qualified ADR, his/her Scan Card remains active and can be used for free re-scan*
ONCE PER CALENDAR MONTH.



*A scan card eligible for a physical free re-scan if the ADR is paid in the month preceding the free scan.

Lifetime Monitoring

If the ADR is cancelled or if the SCS product is removed from the ADR, the Scan Card will be **DEACTIVATED** and the Lifetime Monitoring stops.

Scan Cards can only be **REACTIVATED** by Nu Skin® in case the ADR was deleted by mistake and the Scan Cards remain in the same ADR. ADR orders should be paid.

A Scan Card **CANNOT BE MOVED** from one ADR to another ADR.
